



# UAW Local 4121 Membership Election & Dues Deduction Form

**Our strong majority membership helps us win improvements at UW and beyond.**

Every Academic Student Employee (ASE) who becomes a dues-paying member of the union helps strengthen our advocacy. If you choose to decline membership you are still required to pay the Union a service fee and you waive your right to participate in Union decisions.

**Count me in the majority! I accept membership** in UAW Local 4121 and authorize UW to deduct from my pay and remit to the union my one-time \$10 initiation fee and monthly membership dues in accordance with the UAW Constitution (currently 1.44% of my gross monthly pay). Unless revoked, this authorization is to remain in effect as long as I am a UAW member and working as an ASE.

**I want to help make our Union stronger!** Please contact me about how I can get involved.

**I decline membership** in UAW Local 4121 and authorize deduction of the required service fee (currently 1.145% of my gross monthly pay) from my paychecks. So long as I am not a member I will not have the right to vote or otherwise participate in Union decisions. Unless revoked, this authorization is to remain in effect as long as I am working as an ASE.

## Voluntary Contributions for UAW V-CAP

**Our V-CAP fund helps us advocate for political change.  
If you're eligible to vote in the U.S., please contribute to help hold politicians accountable.**

Subject to the terms of the collective bargaining agreement, I hereby authorize the University of Washington to withhold each and every month from my earnings, **UAW Voluntary Community Action Program (V-CAP)** deductions in the following amount and to remit such contribution to UAW V-CAP in the manner agreed upon between the University and the Union at any time while this authorization is in effect.

This authorization is voluntarily made. I understand that the signing of this authorization and the making of payments to UAW V-CAP are not conditions of membership in the Union or of employment with the University of Washington, that I have the right to refuse to sign this authorization and contribute to UAW V-CAP without any reprisal, and that UAW V-CAP will use the money it receives to make political contributions and expenditures in connection with federal, state and local elections, that all UAW members may be eligible for V-CAP raffle drawings, regardless of whether they make a contribution to UAW V-CAP, and that monies contributed to UAW V-CAP constitute a voluntary contribution to a joint fundraising effort by the UAW and the AFL-CIO. This authorization shall remain in full force and effect until revoked in writing by me.

I also understand that the guidelines for contributions to UAW V-CAP set forth above are merely suggestions, that I can contribute more or less than the guidelines suggest, and that the Union will not favor or disadvantage me based on the amount of my contribution or my decision not to contribute.

Contributions or gifts to UAW V-CAP are not deductible as charitable contributions for federal tax purposes. All UAW members may be eligible for related raffle drawings, regardless of whether they make a contribution. UAW V-CAP is an independent political committee created by the UAW. This committee does not ask for or accept authorization from any candidate and no candidate is responsible for its activities.
